3) HAZARDS IDENTIFICATION

Potential Health Effects

Inhalation: Inhalation of liquid may induce sensitisation in susceptible individuals. Subsequent exposures may cause allergic reactions in sensitised individuals. Avoid inappropriate handling which may result in liquid generation.

Eye contact: Not irritating to eyes. However, direct contact with the eye should be avoided.

Skin contact: Not irritating to skin. However, prolonged contact with should be avoided.

Ingestion: Ingestion of material is not known to cause significant adverse health effects.

4) FIRST AID MEASURES

5) FIRE-FIGHTING MEASURES

Protection against Fire and Explosions: No special requirements

6) ACCIDENTAL RELEASE MEASURES

Personal precautions: Use the necessary personal protection equipment during any work - see point 8.

Environmental precautions: Do not allow to enter the ground, water or sewage water system. Place in plastic barrels for disposal. Do not mix with other waste materials. Dispose of in accordance with state and local authority regulations.

Methods for cleaning up/taking up: Take up by mechanical mean, preferably with vacuum quipped with a high efficiency filter. Flush remainder carefully with plenty of water. Clean thoroughly the soiled surfaces.

Handling

Keep containers tightly sealed after use.
